Project Summary and Highlights

Summary

Northumbrian Water funding has supported delivery improvements to 0.9 km of water environment at Haltwhistle Riverside Park in West End, Haltwhistle, Northumberland.

The park is an area of reclaimed railway yard to the south of Haltwhistle railway station and is bordered by the River South Tyne. It includes the old railway of the Alston branch line. The area of the former old railway yard is covered almost exclusively by Silver Birch, whilst the riverside has greater diversity of flora but is a much smaller area. There are two water outlets in the park which form a small stream.

The Haltwhistle Riverside Park project, led by South Tynedale Railway volunteers, is endeavouring to develop the neglected railway yard and adjacent riverbank into a valued public amenity and wildlife park, introducing trees and new habitat to encourage more animals and birds into the area.

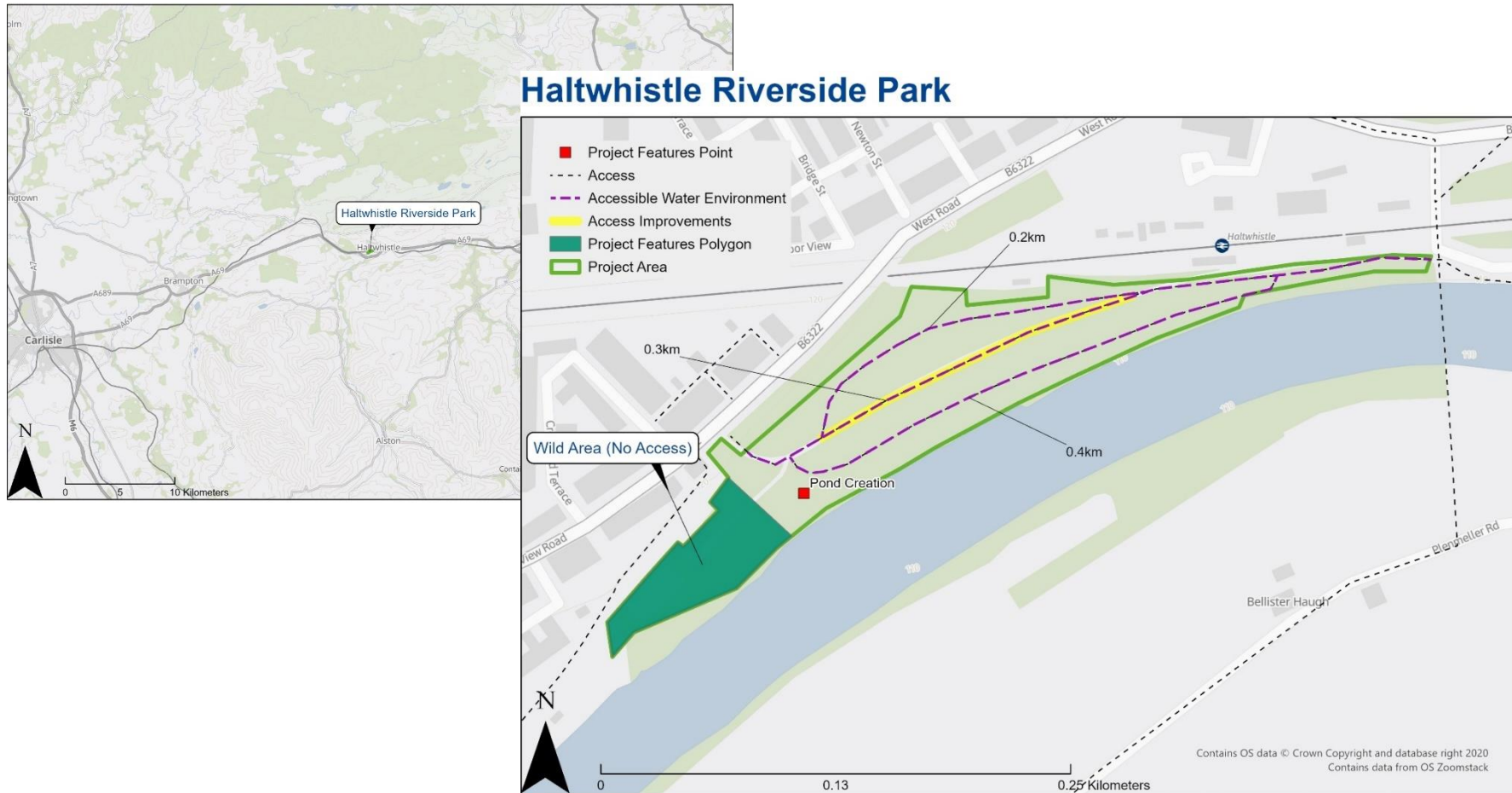
Improvements delivered have transformed the area for the local community, with a plan of more work to do in the future led by volunteers.

Highlights

- Access improvements including new steps and path resurfacing to make the main pathway accessible to all and provide better access to the riverside
- Planting of 300 trees and shrubs, a wildflower meadow and memorial orchard, creating a wider diversity of trees and wildflowers on the site
- Creation of a small wildlife pond which can be used as a dipping pond for children

Expected Project Outcomes	Benefits
<ol style="list-style-type: none"> 1. Restoration of an ‘eyesore’ and fly tipping site into a safe, natural and easily accessed amenity to be used by the community, which will benefit residents and improve health and wellbeing. 2. Access improvements will make the main pathway wheelchair friendly. 3. Picnic benches and seating installation will benefit users of the site. 4. Pond creation will provide a dipping pond facility for children at the site. 5. Health and wellbeing benefits for the local community through delivery of improvements by volunteers working outdoors and engaging with nature, including easily accessible activities such as litter picking, planting wildflower seeds and bulbs and acting as informal park wardens. 6. Project will provide an educational resource for the local school and there are opportunities for other volunteer groups including youth groups to make use of the area. Outputs	
<ol style="list-style-type: none"> 1. A large area at the site has been cleared of rubbish. This uncovered hardstanding material on which a shed was built for the purposes of volunteer tool storage, saving the volunteer team storing and transporting equipment from their own homes. Equipment has been also been donated by residents and local businesses to help restore the site. Compost bins have been created which anyone from the community can use. The site therefore offers a community resource as well as a recreational area for enjoyment. 2. Access has been provided to two ends of the park has been created, with hard surfaces now in place. Steps to the river area have also been provided in two places and have been positively received, allowing more users to access the riverside. 3. A forest school seating area has been created within the park which is now in use. The installation of picnic benches and seating is planned in 2024, with this work delayed due to wet weather. 4. A pond area in a new scrape has been created, and a leaky dam outlet from the pond has been stabilised and the walkway strengthened to create safer access for visitors. 5. Volunteering opportunities have been provided through this project, including tree planting, wildflower meadow sowing and litter picking, providing health and wellbeing benefits to the local community. The “Ellie’s Orchard” area was created by volunteers in memory of local a Chamber of Commerce member. 6. A space at the site has been developed for the local Stomping Grounds Forest School to use. The South Tynedale Railway volunteers have plans to view and monitor the enhanced wildlife now using the through the use of wildlife cameras and surveys.

Wildlife & Biodiversity

Expected Project Outcomes	Benefits
<ol style="list-style-type: none"> 1. Woodland management and thinning of birch and trees affected by ash dieback along with planting hedgerows and trees around the site will improve the appearance of the area as well as providing additional cover and food for wildlife 2. A small pond will provide habitat for frogs, dragonflies, etc. 3. Installation of Bird and Bat Boxes to provide additional habitat 4. Volunteer efforts to manage invasive species aim to remove Himalayan Balsam from the area 	<ul style="list-style-type: none"> ➤ B1: Improves the quantity, quality and connectivity of habitats ➤ B3: Reduces risk or impact of invasive non-native species (INNS)

Outputs

<ol style="list-style-type: none"> 1. Thinning of birch and afflicted ash trees has been undertaken, allowing creation of new deadwood habitat piles across the site. 300 trees, including bushes and hedgerow trees have been planted, and a community orchard. Over 20m² of wildflower meadow has been created with seeds gathered from sites around the Haltwhistle area. 2. A pond area in a new scrape has been created to provide new water habitat for wildlife. 3. Bat and bird boxes have been installed on site, providing nesting opportunities in areas where mature trees are lacking. 4. Himalayan Balsam has been cleared from the site, and this will be an annual task for the foreseeable future which volunteers are committed to continue.

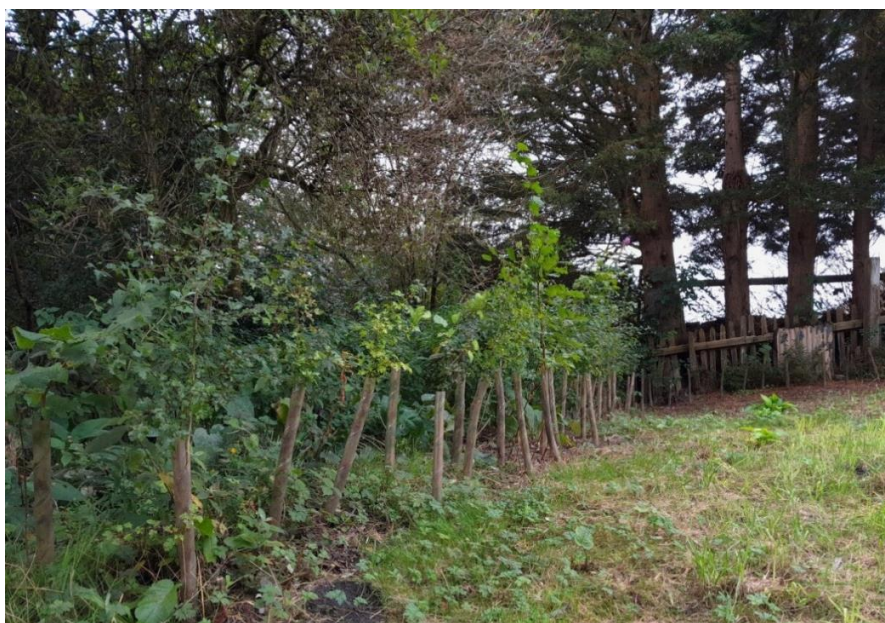

Expected Project Outcomes	Benefits
<ol style="list-style-type: none"> 1. The park provides an arboretum protected from any farming practice or expansion of the town, and greater numbers of trees will help offset CO₂ emissions. 2. Maintenance of the culverts will improve drainage by ensuring that excess water drains into the river. 3. Park has been identified by the Town Council as an asset for the Haltwhistle in Bloom project. 	<ul style="list-style-type: none"> ➤ D1: Provides resilience and adaptation to climate change and/or reduces the risk of flooding ➤ D2: Provides benefits to local communities, the local economy or NWG
Outputs	
<ol style="list-style-type: none"> 1. 300 trees were planted in this project, as well as a pond created, which provide habitat and will sequester carbon. 2. The pond outlet has been improved with a leaky dam which been stabilised to improve drainage to the river, and maintenance of the park and all its features will be an ongoing activity for committed volunteers. 3. The park project has involved multiple partners including Haltwhistle Town Council, Railtrack, Karbon Homes, Potts Plant Hire and The Woodland Trust. The Haltwhistle in Bloom project has not developed for 2023, but this site could be an asset for future years due to the improvements and the community legacy delivered in this project.
