The overall purpose of companies providing this information to Ofwat is to allow us to monitor the development of the market. This will help us to identify whether the market is functioning well and what further actions we may need to take to support the development of the market. A well-functioning market should provide benefits in terms of quality of service and efficiency savings, leading to lower costs to customers. A well-functioning market should also be one that enables third-parties to have fair access so that they may compete to provide services.
